EXHIBITOR SESSIONS

NCSS offers its exhibitors the opportunity to submit proposals for commercial presentations during the 98th Annual Conference. Exhibitors may submit proposals for a one-hour session. Proposals are currently being accepted on a first-come, first-served basis on Friday, November 30 and Saturday, December 1.

These sessions are distinct from proposals exhibiting companies submit through the regular NCSS call for proposals. Commercial solicitation is allowed.

Take this opportunity to showcase your products and services in dedicated presentation space on the exhibit floor. Reach current and potential customers with in-depth information or hands-on instruction in a guaranteed session.

General Information

- Sessions are one hour, offered on Friday, November 30 and Saturday, December 1.
- There is no limit to the number of proposals submitted by any one company. Proposals will be accepted on a first-come, first-served basis.
- NCSS will provide a meeting room located one floor above the Riverside Exhibit Hall.
- Sessions will be listed, with descriptions, in the Conference Program as “Exhibitor Sessions.” Information will also be posted on the conference website.
- NCSS will include a sign with a daily listing of presentations.

Fee

- US\$900 (US\$450 for non-profit organizations) for each one-hour session.
- Notification of cancellation must be made in writing by September 28, 2018 in order to receive a partial refund. In the event of such a cancellation, a \$100 service fee will be incurred. If cancellation is made after September 28, 2018, no payments will be refunded.

Audio/Visual Equipment
